Chair Rutherford described the procedures for tonight's public hearing.

3. COMMENTS FROM THE AUDIENCE (6:03 PM)

1. Josh Friedmann, Hillis Clark Martin Peterson, representing Montebanc Management, spoke regarding the City's draft development regulations for the Goat Hill neighborhood and referenced a letter they submitted to the City.
2. Steve Clarke, representing Bill and Monica Moore, owners of property on Goat Hill, spoke regarding the draft Goat Hill regulations.

4. SPECIAL PRESENTATIONS (6:10 PM)

a. Planning Commission Webpage

This item was postponed to the Commission's next meeting.

5. PUBLIC HEARING (6:10 PM)

a. 2044 Comprehensive Plan Public Hearing #2, File No. CAM22-00032

Chair Rutherford opened the public hearing at 6:10 PM and described the public hearing procedures.

Planning and Building Deputy Director Allison Zike welcomed audience members and provided an introduction. She reviewed the 2024 timeline related to the

Comprehensive Plan update, Planning Commission public hearing schedule, what guides the updates, written comments received to date, and written testimony themes.

Ms. Zike reviewed the Land Use Element including land use amendment key themes, growth targets: planning for capacity, land use element amendments versus zoning code amendments, the draft land use element, proposed land use map, potential land use changes, staff recommendation related to implementing policies for potential land use changes, Par Mac request, and potential land use changes along frequent transit corridors.

Senior Planner David Barnes reviewed the Sustainability Climate and Environment (SCE) Element including what does the SCE element do, SCE Element update key themes, study issues, draft SCE goals and policies, and a summary of proposed revisions since Planning Commission briefing.

Senior Planner Lindsay Levine reviewed the Human Services Element including Kirkland human services, draft goals and policies, a summary of the proposed updates, and a summary of proposed revisions since the Planning Commission briefing.

b. **2044 Comprehensive Plan Public Hearing #2: Juanita Neighborhood Plan Update, File: CAM23-00554; Kingsgate Neighborhood Plan Update, File: CAM23-00555; and General Neighborhood Plan Amendments, File No. CAM22-00032**

Senior Planner LeAndra Baker-Lewis reviewed the Neighborhood Plan Updates, including objectives for the Juanita and Kingsgate Neighborhood Plans, community engagement themes, optional draft Juanita Plan Policies in response to community-initiated land use change requests (Michaels and Goodwill sites), land use changes decision timeline, draft Juanita policy (community-initiated land use change request), and general neighborhood plan updates.

Staff responded to Commission questions.

Public Testimony

1. Scott Brady, Kirkland, described impacts to infrastructure from development on the Michaels and Goodwill sites.
2. Ingrid Salmon, Kirkland, commented on transit service near the Goodwill site and the need for housing that is more affordable.
3. Lori McGovern, Kirkland, read from a letter she submitted regarding impacts of development at the Juanita site.
4. Jack Staudt, Kirkland, spoke regarding the Human Services element and senior issues and urged the Commission to consider impacts on seniors in the community.
5. Terry Steel-Kalet, Kirkland, Chair of Kirkland Senior Council, spoke regarding the Human Services element, highlighting a statement approved by the Senior Council with recommended edits for the element.
6. Luke Travis, Kirkland, spoke regarding changes that have occurred in Kirkland, increased cost of housing, and support for allowing dense housing on bus routes.
7. Kay Williams-Prater, Kirkland, expressed support for Lori McGovern's comments.

8. David Prater, Kirkland, expressed support for Lori McGovern's comments.
9. Kate Conant, Kirkland, described her objection to the JB-16 policy recommendation in the revised Juanita Plan.
10. Leif Giering, Kirkland, spoke begrudgingly in favor of the developments in Juanita and at the Goodwill site.
11. Karen Hartman, Kirkland, Secretary for Kirkland Senior Council, described her objection to development on the Michaels and Goodwill sites.
12. Sarah Jokar Deris, Kirkland, spoke regarding the Par Mac CAR, relaying opposition to redevelopment of the site in close proximity to single family homes.
13. James Kumin, Kirkland, described his reluctant opposition to development on the Goodwill site.
14. Mary Ann Timeus, Kirkland, spoke in favor of more affordable housing in Kirkland, including condominiums to provide transition.
15. James Naegle, Kirkland, described his concern with assumptions that Kirkland will be more transit oriented in the future.
16. Bev Marcus, Kirkland, described ways to make housing more affordable and plentiful.
17. Dana Tonkin, Kirkland, described her Market neighborhood and relayed her concerns with housing that the proposed framework would allow.
18. Ken MacKenzie, Kirkland, described impacts from construction of ADUs and apartment buildings on single family residents and additional traffic due to more dense development.
19. Josh Phua described his support for eliminating parking requirements in the Zoning Code
20. Neil Liebeck, Kirkland, seconded the comments made by Luke Travis, Bev Marcus, and Josh Phua, and described his support for dense housing at the Michael's site.
21. Karl Petersson, owner of the property currently leased to Michaels, described opportunities for development on the site.
22. Allison Warner, Balboa Retail Partners, owners of Juanita Goodwill site, described their support for staff's recommendations.
23. Doug Rough, Kirkland, Chair of Juanita Neighborhood Association, described his request to put the Juanita Public Pathway back into the Juanita Neighborhood Plan.
24. William (Forrest) Whitehouse, Kirkland, described his support of transit-oriented development and studying density above 50 units/acre in the SEIS.
25. Shiela Clooney, Kirkland, relayed her preference that Kirkland meet the assigned growth targets and her concern the draft land use plan exceeds growth targets assigned by King County.
26. Scott Hildridge, Redmond, expressed support for Bev Marcus's recommendation to

eliminate design review and Josh Phua's comments to eliminate parking requirements and described benefits of living in a transit walkshed.

27. Liz Hunt, Kirkland, described her concerns with increased density in the Market neighborhood.

28. Mike McMillian, Kirkland, described his and his wife's concerns with high density development on the Goodwill site.

29. Kurt Dresner, Kirkland, commented on how Kirkland has evolved, increased density resulting in more transit, and planning for future Kirkland residents.

30. Jessie Clawson, representing Karl Petersson, proponent for the Michaels site, described the need for housing in the future and the proposal for the Michaels site.

31. Taylor [no last name given], Kirkland, commented on reasons people move to Kirkland and recommended the City meet but exceed its growth targets.

32. Ezelise Carpenter, Kirkland, described her concern with the impacts increased density at the Michaels and Goodwill sites would have on the area's healthcare system.

33. Bea Nahon, Kirkland, commented on the importance of neighborhood identity.

34. Colly Oswell, Kirkland, encouraged the City to prioritize purchasing more green space near the Goodwill site.

35. Barbara Loomis, Kirkland, referred to the Par-Mac CAR, citing the importance of retaining industrial space.

36. Kira Kimkevich, Kirkland, described her concern with impacts to her neighborhood from traffic impacts due to dense development.

37. Elise Fetch commented on the development of the Michaels and Goodwill sites.

There was no further public comment and Chair Rutherford closed public testimony and declared a brief recess.

The Commission began its deliberations. Staff responded to questions and Commissioners provided input.
